

RESOLUTION 2022-05

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE UTOPIA OF MARION COMMUNITY DEVELOPMENT DISTRICT APPROVING A PROPOSED BUDGET FOR FISCAL YEAR 2022/2023 AND SETTING A PUBLIC HEARING THEREON PURSUANT TO FLORIDA LAW AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Utopia of Marion Community Development District (“District”) was recently established by Ordinance No. 07-356 approved by the Marion County Board of County Commissioners, Marion County, Florida, effective December 28, 2007; and

WHEREAS, the District Manager has prepared and submitted to the Board of Supervisors of the Utopia of Marion Community Development District (the “Board”) the proposed operating fund budget for Fiscal Year 2022/2023; and

WHEREAS, the Board has considered the proposed operating fund budget and desires to set the required public hearing thereon.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE UTOPIA OF MARION COMMUNITY DEVELOPMENT DISTRICT, THAT:

1. The operating fund budget proposed by the District Manager for Fiscal Year 2022/2023 attached hereto as **Exhibit “A”** is hereby approved as the basis for conducting a public hearing to adopt said budget.
2. The public hearing on said approved operating fund budget is hereby declared and set for the following date, hour and location:

DATE: September 12, 2022

HOUR: 2:00 p.m.

LOCATION: 421 South Pine Avenue
Ocala, Florida 34471

3. The District Manager is hereby directed to submit a copy of the proposed budget to the Marion County at least sixty (60) days prior to the hearing set above.
4. In accordance with Section 189.016, *Florida Statutes*, the District's Secretary is further directed to post the approved budget on the District's website at least two (2) days before the budget hearing date as set forth in Section 2. If the District does not have its own website, the District's Secretary is directed to transmit the approved budget to the managers or administrators of the Marion County for posting on their website.
5. Notice of this public hearing shall be published in the manner prescribed in Florida law.

6. This Resolution shall take effect immediately upon adoption.
