A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE UTOPIA OF MARION COMMUNITY DEVELOPMENT DISTRICT APPROVING A PROPOSED BUDGET FOR FISCAL YEAR 2022/2023 AND SETTING A PUBLIC HEARING THEREON PURSUANT TO FLORIDA LAW AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Utopia of Marion Community Development District ("District") was recently established by Ordinance No. 07-356 approved by the Marion County Board of County Commissioners, Marion County, Florida, effective December 28, 2007; and

WHEREAS, the District Manager has prepared and submitted to the Board of Supervisors of the Utopia of Marion Community Development District (the "Board") the proposed operating fund budget for Fiscal Year 2022/2023; and

If the District does not have its own website, the District's Secretary is directed to transmit the approved budget to the managers or administrators of the Marion County for posting on their website.
- 5. Notice of this public hearing shall be published in the manner prescribed in Florida law.

6. This Resolution shall take effect immediately upon adoption.
